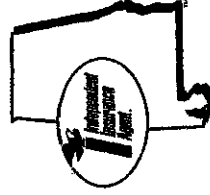

LIFE AND HEALTH

Discover why people buy life insurance. You will be able to identify the uses and features of various policies, determine the provisions and applications of non-foreiture values, settlement options, and endorsements. You will also understand the nature, purpose, and types of annuities. Participants will also analyze disability income contracts by comparing definitions, provisions, exclusions and benefits and develop an understanding of major medical insurance policies and group insurance products. You will be also able to analyze the need, propose a solution, and implement a plan for applying life and health insurance policies to personal life situations.

This course also enables participants to establish the "whys and hows" of insuring a key person in a business. You will understand the concepts and mechanics of split-dollar plans, deferred compensation plans, stock redemption plans, and pension plans.

In addition to all of this, participants will discover successful marketing techniques, the company/producer selection process, and the benefits of selling life and health insurance in a property-casualty agency.

WHAT IS CIC?

The Society of Certified Insurance Counselors (CIC) is a not-for-profit organization provides educational opportunities to help professionals succeed in the insurance industry.
